He said this data was prepared in line with the UN system of Environmental and Economic Accounts and covers all 28 states and one Union Territory. He said, "We are proud that this

specialised handbook is one of the few examples of Natural Resource Accounting anywhere in the world."

22. Centre may hit fiscal deficit target but overshoot borrowing goal (livemint.com) Nov 17, 2022

The government may meet the fiscal deficit target because of improved revenue collection, and as economic output in nominal terms is expected to grow faster than the 11.1% projected in the budget. Nominal GDP measures economic output in current prices without adjusting for inflation.

The finance ministry is preparing to seek a parliamentary nod for spending more than the originally planned ₹39.4 trillion this year owing to a surge in food and fertilizer subsidies. The supplementary demand for grants is likely to be moved in the winter session of Parliament.

Limiting the fiscal deficit at the budgeted level will also signal the Centre's intention towards fiscal consolidation, which is expected to be a hallmark of the budget for FY24. "The government expects to be able to end this financial year with a fiscal deficit either at 6.4% of GDP as originally estimated or slightly below that, although in absolute terms, it may overshoot the original projection. Softening global commodity prices, especially of fertilizer, could mean less spending requirement next fiscal," the person said.

India is spending more on subsidizing fertilizers to soften the blow on farmers and put a lid on food prices as the Russian invasion of Ukraine has sent prices of the key farm input soaring. The government has also extended by three months the free foodgrain scheme introduced during the pandemic, burdening the government's finances.

In September, the Centre marginally cut its full-year market borrowings to ₹14.21 trillion from the original plan of ₹14.31 trillion to signal that it will adhere to the fiscal deficit target. However, market borrowing is only a part of the overall borrowing, with the rest coming from small savings and other funds.

Overshooting the fiscal deficit in absolute terms could mean borrowing more than planned earlier, but this is unlikely to be an issue, experts said.

"In absolute terms, we might need to borrow more because all the nominal variables are higher than budgeted, and it would not put any extra pressure on the market. The government might even try and reduce the fiscal deficit a bit. The government will probably announce a fiscal consolidation glide path because we are well above the 3% fiscal responsibility and budget management (FRBM) target," said D.K. Srivastava, chief policy adviser, EY India.

The FRBM framework mandated the Centre to limit the fiscal deficit to 3% by the end of March 2021, but due to the pandemic, it shot up from 3.5% of GDP in FY21 budget estimates to 9.5% in FY21 revised estimates before coming down to 6.9% in FY22.

An email sent to the finance ministry spokesperson on Tuesday seeking comments remained unanswered at the time of publishing.

On Tuesday, Central Board of Direct Taxes chairman Nitin Gupta said the Centre's direct tax collection is set to exceed budget estimates by a sizable margin. Receipts from direct taxes, comprising personal and corporate tax receipts, after refunds, are expected to rise by more than 25% compared to the budget estimates, he said. The Centre's direct tax target for this fiscal is ₹14.2 trillion. Up to 10 November, direct tax receipts jumped 26% from a year ago to ₹8.71 trillion, representing 61.3% of the total budget estimate for the full fiscal.

#### 23. Govt plans to divest Haffkine Institute, form a separate corporation for medical procurement (hindustantimes.com) Nov 17, 2022

To boost the research related to the infectious diseases and production of the vaccines, the state government is planning to divest Haffkine Institute of its responsibility of procurement of the medicines and equipment required for the government-run facilities. The state government is planning a separate corporation for medical and health procurement with a budget to the tune of over ₹4500 crore a year.

The proposal for constitution of a separate medical services corporation is expected to be placed before the state cabinet in its meeting on Thursday. The poor performance of the institution in research and production of the vaccines over the last few decades, and especially during the Covid-19 pandemic in the last two years, has led the government to the decision according to the officials.

"The procurement of the medicines, machinery and equipment required by all the hospitals and health centres run by state governments, municipal corporations is done by Haffkine Institute. The dedicated corporation for the procurement is being set up for more transparency and speedy procurement. It will also help the Haffkine to concentrate more on the research," said an official from the medical education department.

Located in Parel in Central Mumbai, the Haffkine Institute for Training, Research and Testing is one of the oldest biomedical research institutes in the country. Established in 1899 and named after the legendary scientist Dr Waldemar Haffkine who invented the plague vaccine.

According to the officials from public health the institute has not been able to perform to the expectations in terms of invention and research in the last few decades. "In the first half of the 20th century the Institute extended its scope against cholera, tetanus, diphtheria and rabies. ### **24.** Equity in climate action, contribution to loss & damage funds — what's holding up COP27 talks (*theprint.in*) 17 November, 2022

With just days left for the ongoing COP27 climate summit in Egypt's Sharm el-Sheikh to conclude, negotiations over some of the most crucial issues impacting global climate action are in a deadlock, as talks on climate finance, mitigation, and loss and damage funds, have reached world leaders for consensus.

As the deadline to conclude negotiations drew near, the COP27 Presidency led by Sameh Shoukry said late Tuesday that though progress had been made, certain issues required "higher-level political engagement". The climate summit, which started on 6 November, is scheduled to end Friday, but may stretch for longer if the issues aren't resolved in time, said observers.

India and Australia will lead ministerial consultations on matters related to climate finance — an issue seen as central to the success of COP27, given finance is the means for developing countries to achieve their climate goals.

But observers and negotiators confirmed to ThePrint that rich country groups now want developing countries to contribute to climate finance funds and pay for losses and damages arising from climate change, even as they've failed to deliver on their own promises.

"It is not necessarily good news for developing countries that these issues have reached ministerial consultations, because they are usually used to intimidate us (developing countries) into not participating," said a negotiator with the G77 group of developing countries, adding, "For loss and damage, it's very clear what we want, what we're proposing, and how we want to achieve it".

The Presidency had expressed hope that the outstanding issues would be resolved by 16 November.

#### US, Switzerland push to exclude equity in climate action

The 2015 Paris Agreement on climate change makes it binding for countries to limit global warming to "well below" 2 degrees above pre-industrial levels, while "pursuing efforts to limit the temperature increase to 1.5°C, recognising that this would significantly reduce the risks and impacts of climate change".

According to the latest scientific data, the world is already at 1.1 degrees above pre-industrial levels, and is slated to cross at least 2.3 degrees of warming if drastic reductions in greenhouse gas emissions are not made.

During a review meeting on the implementation of the Paris Agreement temperature goal, called the Second Periodic Review, the U.S. had pushed to "redefine" the goal to limit temperature rise to no more than 1.5 degrees of warming, while seeking to exclude the concept of equity and historical emissions, according to a negotiator who was then in the room.

A few days ago, U.S. special climate envoy John Kerry told the press at COP27 that "some countries" did not want to cooperate to limit the temperature goal to 1.5 degrees.

Developing countries argue, however, that shifting goalposts can double the pressure on low and middle-income countries to cut emissions, without adequate means to do so. Developed countries had nearly 15 years ago pledged to deliver \$100 billion in climate finance by 2020, and still haven't done so.

"We cannot have some kind of situation, where there are only 0.4 degrees left and you distribute the burden of mitigating emissions equally and forget emissions from the past. We need to consider historical emissions, because we are feeling the effects of historical emissions today," said the negotiator referred to above, who is from a middle-income country, adding, "There is also no mandate to change the goal from well below 2 degrees to 1.5 degrees".

Attribution scientists have said this year's heatwaves in India and floods in Pakistan are some of the events made much more likely by the effects of climate change. The U.S. is the largest historical emitter, accounting for nearly a quarter of all emissions since pre-industrial times. The E.U. is the second-largest historical emitter, with 22 per cent of emissions.

ThePrint reached U.S. climate communications office for comment on email, but was told, "Unfortunately, Secretary Kerry and the team are very busy with ongoing negotiations and other commitments, so they would not be available for this request".

Meena Raman, head of programmes at the Third World Network, an UN-approved observer of the negotiations, confirmed to ThePrint that Switzerland also opposed the concepts of equity and historical emissions during discussions on climate mitigation. Switzerland leads the Environmental Integrity Group (EIG), which comprises five other countries — Mexico, Liechtenstein, Monaco, South Korea, and Georgia.

The Print reached the Switzerland Federal Department of Foreign Affairs on email for comment, but received no response till the time of publication of this report.

"During the Mitigation Work Programme, the EIG sought to delete any mention of equity in the context of scaling up mitigation. When developed countries insist on limiting global warming to 1.5 degrees without acknowledging equity, historical emissions, and the common but differentiated responsibility of tackling climate change, it indicates that developing countries will have to pick up the slack," Raman said.

During a press conference Wednesday, COP27 ambassador Wael Aboulmagd said the presidency was trying to find a common ground between groups of countries on the issue.

"The entire Paris Agreement should be guided by equity and common but differentiated responsibilities. This is a conversation that takes place every year. We are patrons at this time and we are trying to find a common ground. We will have to find the right language to accommodate differentiation," he told reporters Wednesday.

#### Footing the climate change bill

The contentious issues of finance — particularly the contours of a new finance goal that will kick in 2025 onwards, as well as finance meant for loss and damage, have also landed in a deadlock.

On Wednesday, the Alliance of Small Island States (AOSIS), a group of 39 countries, put out a statement saying the "inaction of developed countries has the potential to stall talks and land a devastating blow to the hopes of the developing world for a loss and damage funding facility".

Developing country groups have demanded that a finance facility that can provide immediate assistance be set up for developing countries that can no longer adapt to the effects of climate change. The U.S. has blocked the proposal, according to a press release by the Climate Action Network, a global network of more than 1,800 civil society organisations.

Frans Timmermans, executive vice president for the European Green Deal, European Commission, told reporters Wednesay that the EU was prepared to pay for losses and damages, but said, "I think everybody should be brought into the system on the basis of where they are today. So if you freeze the time, some countries that today have huge financial potential and grown enormously could be off the hook in contributing to supporting the most vulnerable in the world."

According to the EU, large economies like China — "one of the biggest economies on the planet" — should contribute to climate finance funds, including for loss and damage. Developing country negotiators have pointed out that this undermines the Paris Agreement and its convention, which lists China as a developing country.

But the interest in expanding the donor base for climate finance outside the framework of the convention is growing in popularity, two COP27 negotiators told ThePrint. Expanding the donor base to include developing countries, who are facing the brunt of climate change, puts less pressure on richer countries to be more ambitious with their own commitments, they added.

"The U.S. has proposed 'high-income countries except small island states' contribute to climate finance. This could include developing countries," said the negotiator from the G77 group, adding, "We have pushed back saying the convention doesn't include this kind of language."

The issue of loss and damage funding has also entered ministerial consultations, the Presidency announced.

"There are very divergent views on the issues. We are guiding the ministers overseeing this. We have said we want something meaningful on this. We owe it to the countries at the frontlines of the climate crisis. In this setting, the idea of a "smart city" combines information and communication technology (ICT) with numerous physical devices linked to an Internet of Things (IoT) network in order to connect with inhabitants and improve the effectiveness of local operations and services. City municipalities may engage directly with both community and city infrastructure, thanks to smart city technology, which also enables them to keep an eye on what is occurring in the city and how it is changing. ICT is utilised to improve the quality of urban services, their effectiveness, and interactivity, as well as to cut costs and resource usage and improve citizengovernment interaction. Frameworks for smart cities are created to control urban traffic and enable quick responses. The concept of a smart city depends upon gathering data and information that is further used to improve the processes, operations and governance systems of the city. Furthermore, this data is leveraged for managing resources, assets and services effectively and efficiently. A smart city is driven by information systems and aids the

monitoring and managing of utilities like power plants, water supply networks and garbage disposal to services like schools and hospitals.

Additionally, the spread and support of discourse on sustainability have also significantly influenced how our cities are planned and developed. According to the World Bank, smart cities make the process of urbanisation more inclusive through the integration of migrants and the impoverished into the city; bringing together the formal and informal sectors; connecting the urban centres and peripheries; and providing services for both the rich and the poor. These smart and digital cities with embedded networks of surveillance also offer protection and security through an enhanced criminal investigation mechanism.

Rethinking cities to make them more liveable, inclusive, and integrated is a key component in promoting smart cities. Smart cities need to build fair, participatory, sustainable, inclusive, and all-encompassing urban development policies and planning in order to achieve these feasible goals. Moreover, to better plan for expansion and handle the day-to-day operational issues, we must provide our cities with dynamic mechanisms. This, therefore, facilitates proper strategic planning, development, and management activities that serve as a coherent vision for the future of urban ecosystems in our smart cities. In order to improve the quality of life and lessen the environmental impact of urbanisation, a sustainable smart city with environmental, social, economic, and cultural dimensions must be established.
