**26.** Freebies, a surefire recipe for disaster (dailypioneer.com) 17 November 2023

Due to political reasons, the Govt is less likely to be interested in curbing freebies, so other organs of the state like the judiciary should come forward to oppose it

Election is the time for political parties to inform voters about their policies and proposed programs, through their election manifestos. In the past, all political parties have been wooing voters with their promises in the form of programs, but the nature of election promises has changed in the last decade and a half. In these promises, instead of policies and programmes, the announcement of cash transfers and free schemes has taken precedence over policies and programs. Announcement of various freebies, including cash transfers to women, farmers, students and sometimes minorities and weaker sections, free electricity, free water, free travel to the entire women etc., has now become a common phenomenon.

In Madhya Pradesh, apart from waiving off the loans of farmers, the Congress party has also announced many other free schemes like free electricity, gas cylinder subsidy, Rs 1500 per month to women, unemployment allowance of Rs 3000 to youth etc. Similar announcements have been made by different political parties in Madhya Pradesh and other states going into elections. Every possible effort is being made to woo the voters. In such a situation, it is a matter of concern, whether this is a healthy trend for our democracy. Will our governments be able to fund these free schemes? Will the debt burden on state governments increase

#### **Increasing debt in states**

This trend of freebies is now spreading in many states of India. In the elections to be held this month, political parties have made a series of announcements of freebie schemes. We are hearing daily about free electricity, free transport, transfer of money to women, unemployment allowance to youth, etc. along with free vehicles and many other freebie schemes. Some time ago, the Reserve Bank of India and the Comptroller and Auditor General of India (CAG) published data in their respective reports about the increasing debt of the states due to freebies and have expressed concern over these freebie schemes and rising debt burden of the states.

According to the Fiscal Responsibility and Budget Management (FRBM) Act, the target debt-GSDP (gross state domestic product) Ratio, in any state, should not exceed 20 percent. But as per CAG, in most of the states of the country, this ratio is much more than the targeted one. It reached 48.98 per cent in Punjab, 42.37 per cent in Rajasthan, 37.39 per cent in West Bengal, 36.73 per cent in Bihar, 35.30 per cent in Andhra Pradesh, 31.53 per cent in Madhya Pradesh, 27.80 per cent in Telangana, 27.27 per cent in Tamil Nadu and 26.47 per cent in Chhattisgarh. If the debt on state government enterprises and the guarantees given by the state government are also added, then by 2020-21 the debt to GSDP ratio in Rajasthan would be 54.94 per cent and in Punjab, it would be 58.21 per cent. In Andhra Pradesh also it has been estimated at 53.77 per cent, it is 47.89 per cent in Telangana and 47.13 per cent in Madhya Pradesh. In West Bengal and Bihar, it's 40.35 per cent and 40.51 per cent respectively, and in Tamil Nadu, it is 39.94 per cent. CAG also reported that the debt of the states is continuously increasing compared to the target ratio. Regarding Andhra Pradesh, the Reserve Bank says that after Punjab, Andhra Pradesh is the second state in the country with the highest spending on free schemes. It is noteworthy that in Punjab, 45.5 per cent of the total tax revenue is being spent on free schemes and in Andhra Pradesh expenditure on freebies is 30.3 per cent of total tax revenue. Talking about the state's GDP, in Punjab 2.7 percent of the state GDP is spent on free schemes annually and in Andhra Pradesh it is 2.1 percent. Apart from this, in Madhya Pradesh, 28.8 per cent of the tax revenue is spent on subsidies, and in Jharkhand, it is 26.7 per cent.

#### Impact on essential expenditure

When a province spends such a large proportion of its tax revenue on free schemes, not only capital expenditure on infrastructure would go down, due to increasing debt of the state governments, but social services like education and health as well as transport and other essential services will also be impacted. For the development of any state, it is imperative to increase investment in infrastructure. Lack of infrastructure affects investment and hence the development of the state. Therefore, it is necessary to speed up the development of the country by curbing the free schemes offered by the states.

Impact on ratings Due to increasing debt the economic rating of the country is being impacted. If this continues, our country will not only have difficulty in getting new investments but our companies and government will also have to pay higher rates of interest on borrowing from foreign countries. That is, increasing debt is not only creating fiscal imbalance but is also affecting the ability of state governments to run welfare schemes and is also blocking the path for the development of the country and industry in particular. <u>https://www.dailypioneer.com/2023/columnists/freebies--a-surefire-recipe-for-disaster.html</u>

# 27. Do it via UIDAI: States shouldn't create separate biometric databases. Multiple datasets increase security risk (timesofindia.indiatimes.com) November 17, 2023

Biometric collection to establish identity is now commonplace across different levels of government. Bengal now has a law that mandates biometric collection as part of the process of recording marriages. Submission of biometrics is mandatory for both the couple and accompanying witnesses. Governments may have good reasons to increase the stringency level to establish identity. Bengal's aim to prevent trafficking is an example. But this can be done without collecting biometrics at all levels.

Aadhaar is based on biometrics. As on September 29, 138 crore unique Aadhaar numbers had been generated, which covers almost the entire population. Bengal, for instance, had recorded an Aadhaar saturation level of over 90% by March 2021. Securing its Aadhaar database is a core function of UIDAI, the body entrusted with managing the ecosystem. Its functioning is subject to CAG performance audits. However, if biometric collection is carried out at different levels, it undermines the safety of the entire database because safety protocols vary. Breaching of one database will compromise all of them with the same data.

In the case of Bengal, officials have said that the data is encrypted to ensure safety. It's a good practice but global experience shows that encryption raises the level of difficulty for hackers but doesn't eliminate it. No database is entirely safe and securing it is a constant challenge for legitimate custodians of data. FATF, the inter-government agency combating money laundering, has warned that biometric characteristics can be stolen in bulk from central databases. In 2015 more than 5 million fingerprint records were stolen from the US government's networks. Therefore, in the interest of safety, collection of biometrics should be limited to UIDAI as it reduces potential targets.

Governments can continue to impose the level of stringency needed to verify identities for their purposes by tapping into the UIDAI database. As financial intermediaries do, state governments can authenticate identities in real time by utilising UIDAI's Central Identities Data Repository. ## **28.** Just-in-time release of central funds to cut borrowings *(financialexpress.com)* November 17, 2023

#### Under new mechanism, CSS funds to be in RBI custody, rather than in state treasuries.

The Centre is planning to roll out a new mechanism that would remove the floating of funds for centrally sponsored schemes (CSS) with the state treasuries and various statelevel nodal agencies. This would let the Centre cut interest costs by ensuring that borrowings are undertaken just in time to meet the actual requirement of fund release.

Currently, interest payments by the Centre are nearly half of its net tax revenue. And at any given point of time, as much as Rs 1.5-2 trillion of central funds lie with state treasuries/agencies.

According to the plan, the Centre will require each state agency to open an account with the Reserve Bank of India, which will be authorised by the Centre and the states concerned to release the funds after instruction from the Centre.

Currently, the Centre transfers funds for CSS to state treasuries, and states in turn transfer these along with their own shares, typically 40%, to the implementing agencies. However, many states delay the transfer of central funds as well as their shares to the agency accounts, causing the funds to lie idle.

The Centre has already rolled out a pilot scheme for Jal Jeevan Mission to reduce such floating of funds with three states — Rajasthan, Karnataka and Odisha, a senior official said.

Under the new mechanism, the state implementing agency will maintain an account with the RBI for each scheme. Instead of releasing any money to the agency, the Centre will issue an authorization as per the sharing pattern to the RBI for the scheme, and the state concerned will also give a similar authorisation to the central bank.

When actual payment need arises, the state will move the payment file to the Centre, which will pass it on to the RBI. The RBI, which already has the authorisation, would release the amount to the agency from the Consolidated Fund of India first and then from the State Consolidated Fund.

The advantage of the arrangement is since the funds don't need to be parked either with the state treasuries or the bank accounts of agencies, they won't lie idle in these accounts, while having already flown out of the CFI.

"After learning from the pilot, the mechanism will be rolled out scheme by scheme gradually," another official said.

Besides cutting floats to zero, it would also make things easier for the states as the Centre has clamped down on many states for the delay in the release of funds to implementing agencies and has imposed costs on them.

With some states using the central funds to finance their fiscal deficit, the Centre has also set the penal interest rate at 7%/annum from April 1 on the number of days of delay beyond 30 days in the transfer of Central share to the SNA account.

Of the Rs 1.3 trillion interest-free capex loans to states in aggregate in FY24, the Centre has mandated that the first instalment of 66.6% would be released to each state government as per their share on meeting three fiduciary conditions including proof of deposit of the Centre's share of the interest earned in SNA account for each scheme.

This approach to account for each rupee transferred to states has brought a fair sense of realism into the budget-making process, the second official said.

Since the Centre's borrowing is actually linked to spending requirements, idle funds in CSS were leading to unnecessary interest costs for the Centre. Interest costs account for Rs 10.8 trillion or 24% of the budget in FY24.

The penal interest on treasuries and interest from SNA accounts fetched the Centre around Rs 4,000 crore in FY23, enough to run a few new schemes. In FY24, the interest from unutilised central funds could fetch the Centre over Rs 5,000 crore, sources said.

The CSS spending stood at Rs 4.12 trillion in FY23 as against the BE of Rs 4.52 trillion. Even then, there were Rs 1.8 trillion central funds unspent from the releases of FY23. So, the Centre sought these funds first to be exhausted before fresh releases were initiated from FY24 budget outlays. Given the pace so far, indications are that the Centre would save substantially from the current year's allocation of Rs 4.76 trillion, which it would use to fund new schemes or existing schemes where more funds are needed. <u>https://www.financialexpress.com/policy/economy-just-in-time-release-of-central-funds-to-cut-borrowings-3309107/</u>

## **29.** Nutrition gap: Don't reduce India's food security law to a grain handout scheme (*livemint.com*) Nov 17, 2023

Earlier this year, the National Food Security Act (NFSA) completed a decade, a period over which it has successfully expanded coverage of the Public Distribution System (PDS) to almost two-thirds of India's population. It proved to be a lifeline during the covid pandemic, with the government raising its entitlement from the mandated 5kg per person to 10kg, free of cost. While the quantity hike was rolled down after the pandemic ended, it continues as a free-ration scheme, as against the earlier subsidized price of  $\gtrless 2$  per kg for wheat and  $\gtrless 3$  per kg for rice.

The scheme's expansion also came with its renaming as the Prime Minister Garib Kalyan Anna Yojana (PMGKAY). As part of his election campaign, earlier this month,

Prime Minister Narendra Modi announced an extension of the scheme for another five years. While the PMGKAY's renewed lease in a new avataar may be justified, given spiralling food prices, particularly cereals, the extension and renaming are not just in name, but also in spirit.

The PDS has existed in India for more than five decades and the history of food rations goes back even further, before independence. While it was universal to begin with, it was changed to a targeted scheme after the economic reforms of 1991, with items distributed under the PDS restricted to rice, wheat, kerosene and sugar. However, given problems with targeting, state governments took the lead in PDS reforms, with most states turning the scheme universal again (or quasi-universal). At the same time, competition among political parties led to gradual reduction in the issue price of subsidized foodgrain. So most states on the eve of the NFSA enactment 10 years ago had prices of rice and wheat at  $1 \neq 1 \neq 1 \neq 2 \neq 1$ 

The NFSA was not just a central PDS reform that took its cue from states, it came in the backdrop of India's slow performance on the nutritional front, despite rapid economic growth, and thus laid down the framework for a comprehensive food-security system aimed at improving nutrition and access to food. The PDS was an important part of it but not the only tool. However, the last decade has seen a gradual erosion in the food security architecture as envisioned in the Act of law. It has been reduced to a rice and wheat PDS scheme and renamed the PMGKAY with no effort on several other aspects of the Act vital for a comprehensive food-security paradigm.

While the covid volume doubling was necessary, given the programme's reach and success, it soon became a political instrument (example: its latest extension). A narrow approach which has reduced the NFSA to PMGKAY-led PDS has come at the cost of dilution of several provisions in the original law. Despite a larger population, beneficiary coverage remains fixed at estimates derived from the 2011 census, excluding more than 100 million beneficiaries. As against a provision of maternity benefits for all pregnant women, the scheme has been restricted to only one child birth. The amount has remained frozen at ₹6,000 per delivery, with no increase in the last decade. Similarly, while rice and wheat distribution under the PDS has seen outlays increase, we've seen insignificant hikes for the Integrated Child Development Scheme and the Mid-Day-Meal scheme. Both are critical for arresting child malnutrition.

The excessive focus on rice and wheat has also had its consequences. While cereals are important, the solitary focus on these two grains goes against the stated objective of the Act, which mandates the government to expand the food basket to include pulses, edible oil and other nutritious food. It has contributed to a skewed production structure, whereby India is a large importer of pulses and edible oil, though self-sufficient in rice and wheat. Unlike the Act's provision for the decentralization and expansion of public procurement, it remains largely concentrated, with north-western states like Punjab and Haryana playing disproportionate roles. The environmental consequences of paddy cultivation in those states are not just visible in declining water tables, but also the practice of stubble burning, which transforms India's capital into an annual spectacle of pollution.

The raison d'etre of the NFSA was to move beyond the limited nature of the PDS and provide a framework for improving nutrition and food security. Reducing the Act to a

free PDS scheme may help the majority of our population access free food, yielding political dividends, but it need not be at the cost of key provisions of the Act that are in dire need of budget support for the sake of India's nutrition and food security. https://www.livemint.com/opinion/online-views/nutrition-gap-dont-reduce-indias-food-security-law-to-a-grain-handout-scheme-11700146226541.html

## **30.** Indian economy still not out of woods, says RBI *(financialexpress.com)* November 17, 2023

Retail inflation has moderated due to monetary policy action and supply side interventions but the Indian economy is still 'not out of the woods yet and have miles to go', said the Reserve Bank of India's (RBI) monthly bulletin on Thursday.

"We are not out of the woods yet and have miles to go, but (inflation) readings of around 5% and 4.9% in September and October, respectively, are a welcome relief from the average of 6.7% in 2022-23 and 7.1% in July-August 2023," the RBI said in its 'State of the Economy' article in the bulletin.

Retail inflation came down to 4.9% in October from the average of 6.7% in 2022-23 and 7.1% in July-August 2023 but remained above the RBI's 4% target. The central bank expects inflation to average 5.4% in 2023-24.

India to emerge as third largest global economy by 2027: FM Sitharaman The bulletin noted that tightening financial conditions is a significant risk to the global outlook going forward. "In India, the momentum of the change in GDP is sequentially expected to be higher in Q3, 2023-24, with festival demand remaining ebullient," the article authored by a team lead by RBI deputy governor Michael Debabrata Patra said.

The demand appears to be resilient with the government's infrastructure spending, an uptick in private capex, automation, digitalisation and indigenisation providing a boost. The RBI also said the calibrated normalisation of surplus liquidity and robust credit growth strengthened transmission during the current tightening phase, although the transmission is still not complete.

The transmission of rates to term deposits has been robust, while savings deposit rates have exhibited rigidity the central bank said. The article further said India's external sector has remained viable, with a modest Current Account Deficit (CAD) financed by resilient capital flows, one of the least volatile currencies in the world and a healthy level of foreign exchange reserves.

The momentum of growth has picked up, taking GDP well above pre-pandemic levels to becoming the fifth-largest economy in the world at market exchange rates, it added.
